***SHOW INFORMATION, REGULATIONS, AND CONTRACT***

On Saturday & Sunday, March 13th and 14th, 2021, the FRCC will hold its annual Spring show at the Boulder County Fairgrounds at 9595 Nelson Rd, Longmont CO. (Pending BCFG reopening in 2021)

Dealer/Applicant signature on this form indicates agreement to abide by the show regulations herein.

Dealer setup will take place between 12:00 to 7:00 PM Friday afternoon, and 7:30 to 8:30 A.M on Saturday morning. The show will be open to the public at 9:00 AM to 5PM Saturday and 9:00 AM to 3:30 PM Sunday. There will be a security guard on duty on Friday from 12:00 PM to 7:00 PM and from 7:30 AM to 6 PM on Saturday and Sunday from 8:00 to 5:00 PM, and overnight security from 7 PM to 7:30 AM Friday night and from 6:00 PM to 9:00 AM Saturday evenings. Each dealer is responsible for collection/payment of any state sales taxes due. There is a City sales taxes here, you will need to use a City of Loveland special event form and there are no state taxes on coins and bullion.

Ample electrical outlets are available along the walls but dealers must furnish their own extension cords as well as any showcases, signs or lights, and table coverings if you want.

We will have both 6 foot and 8 foot tables available, as well as backup tables provided at no charge. ***The fees for 8 ft tables are \$100 and \$80 for 6 ft tables. Combination corner tables as outlined in the table layout guide are \$170.*** Table assignments are based on previous commitments for tables at our shows, then after that a first come first served basis, so make your reservations early! There will be a limit of 70 tables at this show. Payment for tables must accompany your application. Tables must be occupied only by the dealer or an employee and should be occupied throughout the show. Cancellations are permitted within ONE month of show date. After that point, no refunds will be made unless the table is re-sold to dealer pre-approved by FRCC coin show committee. Smoking is not permitted in the showroom and firearms are not allowed in the building, except for the security guard, unless you have a permit in your possession to carry one. **No children allowed behind the dealers tables at any time.** Only two staff per Dealer during this event. Additional requirements are attached due to Covid-19 limitations.

Plan on having a table and sign up soon, as we expect to sell out quickly.

Also planned are hourly drawings with hourly prizes for our customers.

## **Guidelines and changes for FRCC Coin Show due to Covid-19 restrictions and requirements**

- Good news we have found a location to have a Show in September. This will be one of the few shows held so far this year, in Colorado, so expect to see lots of pend up demand.
- The Boulder County Fairgrounds is still closed and is expected to be so for the foreseeable future so we had to find an alternative venue.
- The new location is at the Loveland Outlet Mall 5720 McWhittney Blvd. Loveland CO
- Some of you may have attended gun shows here in the past.
- If you paid for a table(s) for the March show your payment will be applied to the same size table for this event.
- The venue is a different size and shape so locations will change from what you historically were able to request at the BCFG
  - We will do our best to get a similar set up but we may not be able to accommodate all your requests
- Because this site is larger, we also can add tables. If you currently don't have a table or would like to add a table, please contact me.
  - If I currently have a contract on file there is no need to fill out a second one. If you would now like to participate in this show please fill out an application and contract. If you wish to add tables a simple email will work. If you received a refund and would like to be part of the show, please fill out a new contract.
- The rent for this facility is considerably higher than the fairgrounds. But we are able to hold the price for tables the same with one adjustment to our normal program.
- We will not be providing food to the dealers and staff for two reasons.
  - Compensate for the increase facility rental cost.
  - Address safety concerns with Covid-19.
- Masks are mandatory for all dealers, staff and guests per Larimer County requirements. Anyone not wearing a mask will be asked to leave the building.
- Social distancing will be required and traffic will follow a one-way pattern laid out on the floor.
- The number of people in the building at one time will be limited to 150 including dealers, security, FRCC staff, and guest per Larimer County guidelines. This will be tracked at the front and once we reach capacity no one else will be allowed to enter until some leaves the building.
  - In order to maximize the number of buyers we can get into the show at one time, we are limiting dealer staff to two people per dealer/company that can be in the building (working tables) at any one time.
- The youth auction is cancelled due to Covid-19 concerns and size/capacity concerns
- Hand sanitizer will be available at the sign in table. Dealers are also encouraged to provide hand sanitized at their tables for those customers touching your coins.
- The hours of the show have been adjusted slightly on Sunday. New hours 9:00 AM to 3:30 PM.
- The same level of security will be provided for this show as we always provide.
